Infrastructure for affordable housing development near Hardeeville SC		Hilton Head Regional Habitat for Humanity owns 161 acres outside of Hardeeville, SC, in what is know as the Honey Hill Road property. This \$2,000.000 is to start planning for and adding the infrastructure for this development. Fundraising plans are being developed to secure the additional funds needed to complete the community. The first funds to be spent on the project will be these state funds.

Please explain how these funds will be used to provide a public benefit:

While our engineers are still developing a layout, this will be a large scale (probably 80-160 houses) Habitat community. Each family must meet program requirements including earning between 30-80% of the area median income. They will have completed at least 300 hours of sweat equity and taken at least 20 hours of new honeowner classes to prepare them for successful homeownership. Most of the housing construction will be completed by volunteers, so we are able to keep the cost of each house low. Once complete, the homeowners will have an affordable monthly mortgage payment that is around 30% of their monthly income.
